 - Teacher should have an open mind to accept the changes brought into the system whenever and wherever they are required.
 - Teacher shall not do anything contrary to the interest of the students and the system.
 - Teacher essentially a disciplinarian who should be punctual, respectful and abide by the rules and regulations of the system.
 - Teacher should have the qualities of leadership, courage, communication, patience and empathy.
 - Teacher should be responsible to interact positively with parents and other stakeholders in educating the students to attain the concept of education.
 - Teacher should be on time to perform his/her duty.

- No teacher shall be absent from the duty without prior permission of the Head of the Institution.
- No teacher shall leave head quarters without the prior permission of the competent authority.
- If any of urgency happens to leave the station, teacher shall inform to the Principal through obtaining the consent of their concerned HoD's.
- No teacher shall make any adverse statement/publish/write against to the interest of the Institutional values.
- No teacher can engage directly or indirectly in any trade or private tuition or undertake employment outside his official assignment for any of his/her monitory benefit.
